



NOTICE

Draw of Lots for Constitution of School Level Fee Regulation Committee (SLFRC)

Pursuant to the Hon'ble High Court order whereby notice on the challenge to the 2025 Act & Rules as well as order of DoE dated 24/12/2025 was issued to the Directorate of Education & ors and the direction of the Hon'ble Court to extend the date of commencement of procedure to constitute the SLFRC by 10 days, various Association & Forum of Schools have filed SLPs before the Hon'ble Supreme Court of India. The matter is sub-judice and thus, it is appropriate to await the directions of the Hon'ble Apex Court on the subject matter.

However, in so far as commencement of the procedure to constitute the SLFRC, this notice / communication is issued without prejudice to the rights & contentions of School Management on the challenge to the validity of the 2025 Act & Rules as well as DoE's order dated 24/12/2025. The Schools are informing the parents about the aforesaid development, while writing to them about the constitution of the SLFRC procedure. This is for information of all.

Given the fact that there were winter vacations, this communication is being issued today.

This is to inform all concerned that a draw of lots shall be conducted for the selection of Parent and Teacher Representatives to the School Level Fee Regulation Committee (SLFRC).

Purpose of the Draw: The draw of lots is being conducted for the constitution of the SLFRC, to examine and decide matters relating to fixation and regulation of school fees in a transparent manner.

Categories for Selection:

- Five (5) Parent Representatives
- Three (3) Teacher Representatives
- The selection shall be made through a transparent draw of lots, along with preparation of a waiting list of 10 parents, strictly as per the Rules.
- An unwilling parent whose name is drawn shall be required to submit an "Unwillingness Application" to the Directorate of Education (DoE) through the school.

Eligibility

- Parents/guardians of students presently on the rolls of the school and all regular teachers of the school shall be eligible and shall be included in the draw of lots.

- Parents/guardians of students admitted under the EWS/DG/CWSN categories, who are exempted from payment of fees, shall not be eligible for selection as Parent Representatives.

NOTE: Certain **facilities**, round the year, **are being provided to students** and consequent to the National Education Policy 2020, additional facilities and corresponding infrastructure is be catered to in addition to deployment of additional staff. The school shall not compromise on these aspects as well as remittance of statutory payments to be made as a sequel to the recommendations of the 8th Central Pay Commission and also, under the New Labour Code, and such other statutory enactments. Hence, the selected parents will be responsible for factoring all these aspects to **Fee Proposals to be decided**. A pragmatic approach by parents to avoid accumulation of their liability will be in the best interest of the Students as well as the Institution.




